

## **TERMS & CONDITIONS**

Welcome to Texas Hemp Cooperative by Rudy Montes ("TxHC"). Please read these Terms and Conditions of Use ("Terms and Conditions") completely and carefully before using texashempco-op.com (the "Site"). By using the Site, you express your unconditional agreement to follow and be bound by the Terms and Conditions of Use in their entirety.
